

ABOUT US:

The National Institute of Public Administration (NIPA) is a management development institute (MDI) under the **Office of the President** dedicated to enhancing the skills and competence of public service employees in Zambia. Government has reintroduced the **mandatory Public Service Training** and **Certification Programme** (PSTCP) at NIPA to build capacity and professionalize the public service **effective January 2024**.

Job Overview:

The Research Ethics Officer will be responsible for ensuring that all research activities conducted within NIPA adhere to ethical standards, regulatory requirements, and best practices. This position is integral to maintaining the integrity and credibility of research undertakings at NIPA.

- ✓ Develop and implement policies, procedures, and guidelines for ethical research conduct.
- ✓ Facilitate the review of research proposals, protocols, and projects to ensure compliance with ethical standards and regulatory requirements.
- ✓ Provide guidance and support to researchers, faculty, and staff on ethical issues related to research.
- ✓ Conduct ethics training sessions and workshops for researchers and research
 teams.
- ✓ Monitor and evaluate ongoing research activities to ensure continued compliance with ethical standards.
- ✓ Collaborate with relevant stakeholders, including regulatory bodies, ethics committees, and research partners.

- ✓ Investigate and address any ethical concerns or violations related to research activities.
- Maintain accurate records and documentation related to research ethics oversight.

Qualifications and Experience:

- ✓ Bachelor's degree in Humanities and Social Sciences
- ✓ School Certificate
- ✓ Minimum of 3 years of post-qualifying experience in research related undertakings.
- ✓ Familiarity with national and international ethical guidelines and regulatory frameworks.
- ✓ Strong analytical, communication, and interpersonal skills.
- ✓ Ability to work collaboratively in a multidisciplinary environment.
- ✓ Certification or training in research ethics will be an added advantage.
- ✓ An active member of a professional body
